OUR 21st Century After School Program

OUR PURPOSE

The primary focus of the 21st Century After School Program (ASP) is to provide extra academic support and academic enrichment for students who may struggle with school. The 21st Century Community Learning Centers' (21st CCLC) grant based programs place a strong emphasis on hands-on learning in Science, Technology, Engineering, Arts and Math.

21st CCLC ASP goals include:

- Supporting an increase in student achievement
- Increasing parental and family engagement
- Engaging student-centered activities
- Providing additional academic support, including homework assistance, tutoring and academic skill building

OUR STUDENT ELIGIBILITY

21st CCLC ASP has over **2300** eligible students at its school sites. Eligibility includes:

- ✓ Current enrollment in a school with an ASP
- ✓ Demonstrated academic need based on test scores and teacher/counselor recommendation (grant-funded sites)
- ✓ Open enrollment (fee-based sites)

- Competitive Grant Funded: **over 800**

- Fee-Based: **over 120**

OUR FUNDING SOURCES

- **COMPETITIVE GRANTS:** Three 21st Century Community Learning Center grants for eight program sites and a summer program. STEM Innovation Grant

OUR PURPOSE

The Alaska Native Education (ANE) Program, under the federal Indian Education Act of 1972 and reauthorized under the Every Student Succeeds Act, provides supplemental programming and services to support the needs of Alaska Native and Native American students.

OUR GOALS

The overall goal of the ANE Program is to improve academic achievement for all eligible students by:

- Increasing parental and family engagement
- Promoting and providing culturally relevant and enriching experiences to include place-based learning
- Encouraging educators to intentionally integrate Indigenous knowledge and traditions throughout the curricula
- Improving academic achievement in all content areas

The ANE Program is made up of over **2100** Alaska Native and Native American students from over **550** tribes. Required documentation includes:

- ✓ Title VI Student Eligibility Certification
- ✓ Tribal enrollment verification: *Certificate of Indian Blood, Tribal ID, Tribal enrollment number, and other acceptable documents*

The ANE Program provides cultural enrichment opportunities for all students in the Fairbanks North Star Borough School District.

OUR English Language Learners Program

OUR PURPOSE

Under the language provisions of the Civil Rights Act of 1964, the English Language Learners (ELL) Program provides specialized instruction to students whose limited English proficiency impacts full participation in an educational environment.

OUR GOALS

The ELL Program develops students':

- Basic interpersonal communication skills in English
- Confidence in their social and academic learning environment and peer interactions
- Cognitive academic language proficiency in English
- School communication through access to Language Interpretation services for students and parents

OUR STUDENT ELIGIBILITY

Over **400** students are eligible for the ELL Program. These students come from over **55** different language backgrounds. Eligibility includes:

- ✓ Students who speak a language or languages other than English
- ✓ **OR** students who speak another language in addition to English
- ✓ **OR** students who have a language other than English spoken in their home
- ✓ **AND** who are academically achieving below grade-level

If a student is found to be eligible for the ELL Program after screening is completed, parents are notified.

Continued Student Eligibility is based on required annual English Language Proficiency Tests

OUR STUDENTS SERVED

Over **400** students are served annually.

OUR McKinney-Vento Education Program

OUR PURPOSE

The McKinney-Vento Education Program’s primary focus is to ensure that each student who experiences homelessness during the course of a school year has equal and full access to the same education provided to other students.

OUR GOALS

The McKinney-Vento Program addresses barriers associated with homelessness by:

- Facilitating school enrollment, attendance, and full opportunity to participate in extracurricular activities
- Reducing barriers to academic achievement
- Facilitating access to higher education
- Coordinating with local agencies to identify and provide stabilizing supports
- Providing training to school personnel to ensure students are identified

OUR STUDENT ELIGIBILITY

Over **300** students per year are identified through a referral process and are eligible for services based on their living situations. Some of these situations include:

- ✓ Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason
- ✓ Living in emergency or transitional shelters
- ✓ Living in hotels, motels, trailer parks, or campgrounds due to lack of alternative adequate accommodations
- ✓ Living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or other similar settings



OUR STUDENTS SERVED

Over **300** students are annually identified and served. Typical supports provided include: school meals, clothing for school, school supplies, tutoring, and transportation.

OUR FUNDING SOURCES

- **FORMULA GRANT:** Identification and supports to remove barriers are provided by a required set-aside of Title I-A
- **COMPETITIVE GRANT:** Academic monitoring and assistance is provided by a McKinney-Vento sub-grant
- **FNSBSD OPERATIONAL FUND:** Transportation to school of origin

OUR Migrant Education Program

OUR PURPOSE

Title I, Part C of the Elementary and Secondary Education Act provides supplemental funds for the Migrant Education Program to meet the identified needs of migrant children that result from their migratory lifestyle.

OUR GOALS

The primary goals of the Migrant Education Program are to ensure that all eligible students:

- Reach challenging academic standards
- Graduate from high school
- Have supports targeted toward increasing academic achievement

OUR STUDENT ELIGIBILITY

There are over **550** eligible migrant students. Students may be eligible for services if they meet the following criteria:

- ✓ Not older than 20 and entitled to public K-12 education enrollment under state law
- ✓ Made a qualifying move as, with or to join a migratory fisher or agricultural worker during the last three years
- ✓ The qualifying move is from one residence to another outside of FNSBSD boundaries due to economic necessity
- ✓ The move consists of a total of at least 7 nights and 8 days, consecutive or nonconsecutive, in a calendar year, to engage in the migrant activity

OUR STUDENTS SERVED

Approximately **85** students currently receive tutoring services. **ALL** receive free school meals and assistance with: school enrollment, family engagement, literacy materials for the home, and basic needs evident from their migrant lifestyle.

OUR FUNDING SOURCES

- **FORMULA GRANT:** Title I-C federal grant, passed through the State, based on a 3-year comparison of migrant students identified and served in Fairbanks, compared to school districts across the state

OUR Title I Program

OUR PURPOSE

Title I, Part A, provides educational program assistance to school districts and schools with high numbers of children from low-income families to ensure that all children meet challenging state academic standards. The overall focus is to upgrade each Title I school's entire educational program to improve achievement for all students, particularly the lowest-achieving students.

OUR GOALS

- Increase family-school engagement in support of student achievement
- Identify and provide intervention supports for the lowest performing students
- Enhance teacher professional practice through targeted professional development based on data-identified needs

OUR TITLE I ELEMENTARY SCHOOLS

Title I schools are schools with 40% or more eligible for free school meals. Each Title I school uses its supplemental funds to focus on prioritized goals set each year.
