The purpose of this memo is to inform the Board of the district's participation in the following collaborative projects that do not involve the district receiving a direct grant award, sub-award, or contract.

#### MEMORANDUMS OF AGREEMENT

### Fairbanks Community Mental Health Services

The district has entered into a Memorandum of Agreement with FCMHS to improve the quality of care for students at Joy Elementary and their families.

#### Fairbanks Education Association

The district has entered into a Memorandum of Agreement with FEA for the National Education Association Opportunity Audit and Checklist to identify areas of need across the district and offer professional development to address needs.

#### Fairbanks Native Association

The district has entered into a Memorandum of Agreement with FNA to provide social emotional support and tutorial services to Alaska Native and American Indian students at Ryan Middle School and Lathrop High School.

### Southeast Regional Resource Center

The district has entered into a Memorandum of Agreement with SERRC for the Igniting Fires for Culturally Proficient Leaders project to develop, demonstrate, and evaluate a comprehensive framework to build culturally proficient schools in which diverse people value each other and interact with respect.

### Stanford University

The district has entered into a Memorandum of Agreement with Stanford for Validating the Effectiveness of Mindset Math Summer Program to research and document the effects of a 30-hour summer math curriculum designed at Stanford

# United States Army Garrison Alaska

- The district has entered into a Memorandum of Agreement with the USAGA to provide School Age Services children and staff a temporary shelter at Arctic Light Elementary in the event of an evacuation during months with extreme temperatures.
- The district has entered into a Memorandum of Agreement with the USAGA to ensure that the FNSBSD Emergency Response Plan is properly integrated with the Installation Emergency Management Plan because Arctic Light Elementary is located on Fort Wainwright.

### University of Alaska Fairbanks

- The district has entered into a Memorandum of Agreement with UAF to increase elementary students' awareness of continuing education opportunities through mentorship with UAF students, faculty, and alumni. This MOU is to focus specific attention on under-served and under-represented groups at Hunter Elementary.
- The district has entered into a Memorandum of Agreement with UAF eCampus to formalize support for high school students that take UAF eCampus courses for dual enrollment and receive credit for courses from both the college and the high school.
- The district has entered into a Memorandum of Agreement with UAF International Arctic Research Center for the Arctic Harvest Winterberry Citizen Science project to investigate how shifting seasons could affect when berries are available to animals and people.

#### LETTERS OF SUPPORT

### Alaska Department of Education and Early Development

The district has submitted a Letter of Support for the Alaska DEED's Project AWARE. If funded, this partnership would expand mental health related interventions and services for school-aged youth and their families.

#### Family Centered Services of Alaska
