WHEREAS, in August 2019, the Fairbanks North Star Borough Assembly adopted Ordinance 2019-35, amending FNSBC 7.12.120 Capital Improvement Program; and

WHEREAS, the Assembly is required to review capital projects on an annual basis; and

WHEREAS, a lengthy public nomination period for capital improvement projects, to include two public workshops, ended on October 11, 2019; and

WHEREAS, Borough Administration received 94 capital project nominations from borough residents; and

WHEREAS, the Borough Mayor's Office is required to review projects for duplication and forward a capital project submittals recommendation to the Assembly for evaluation and inclusion into the Capital Improvement Program; and

WHEREAS, the School Board shall receive a copy of the Capital Improvement Plan submittals for education facilities, and the School Board shall provide recommendations to the Assembly;

NOW, THEREFORE, BE IT RESOLVED, the Fairbanks North Star Borough Board of Education supports adding the attached list of capital project submittals to the Borough Capital Improvement Program.

# 2019 Additions (School Facilities) to the FNSB Capital Improvement Program

#### Woodriver Elementary School Renovation Phase II

\$6,750,695

The project will include mechanical, plumbing, and electrical upgrades. It will also include interior upgrades not completed in phase I.

#### Weller Elementary School Classroom Upgrades Phase I

\$4,648,181

The flooring and classrooms are in need of upgrades as well as some of the electrical and control systems. This will start the renovation and will include design and planning for the remaining work. Nominated Project Reference Number: 19-46

#### University Park Elementary School Site Improvements

\$1,500,000

The project includes traffic routing improvements to decrease the risk of pedestrian and vehicle encounters and bus/vehicle encounters.

#### Tanana Middle School Classroom Upgrades Phase I

\$9,750,000

The project includes the replacement of casework, cabinetry, shelving, flooring, writing boards, and bulletin boards. Additionally, storage space will be increased and mobile furnishings will be replaced along with other items as necessary in program areas. Student restrooms will be added to the east academic wing. Mechanical, plumbing, and electrical systems that are no longer serviceable will be replaced.

## Pearl Creek Elementary School Traffic Safety

\$1,800,000

The project will include routing changes to better separate parking, parent drop-off, and school buses. In addition, the project will help improve drainage, site lighting, head bolt outlets, and replace deteriorated and aging asphalt in parking lot.

#### Pearl Creek Elementary School Classroom Upgrades Phase I

\$4,746,852

The flooring and classrooms are in need of upgrades as well as some of the electrical and control systems. The project will start the renovation and will include design and planning for the remaining work.

#### North Pole Middle School Classroom Upgrades Phase I

\$11,302,805

The project will include replacement of casework, cabinetry, shelving, student book and coat storage, coloring, writing boards, and bulletin boards. It will also improve lighting if needed, increase storage space, and replace mobile furnishings as necessary and other items in program spaces.

#### Lathrop High School Kitchen Remodel

\$2,585,194

#### Joy Elementary School Classroom Upgrades Phase I

\$5,264,721

The project will include replacement of casework, cabinetry, shelving, student book and coat storage, coloring, writing boards, and bulletin boards. It will improve lighting if needed, increase storage space, and replace mobile furnishings as necessary and other items as needed in program spaces.

The project will include a new roof, roof drains, EIFS, windows, exterior doors, and exterior lighting. Nominated Project Reference Number: 19-45

#### **Anderson Elementary School Renovation Phase II**

\$2,547,132

The project will include a new roof, roof drains, EIFS, windows, exterior doors, and exterior lighting. Nominated Project Reference Number: 19-47

#### School District Administrative Center

\$5,760,189

The project will include a new roof, roof drains, EIFS windows, and exterior doors. Nominated Project Reference Number: 19-48

#### Districtwide College and Career Centers of Excellence (C3E)

\$12,000,000

The C3E program would expand and/or renovate the site capacities of the traditional borough middle and high schools to provide for the development and integration of Career and Technical Education (CTE) and Science, Technology, Engineering, and Math (STEM) programs of study. Each school will have direct pathways to college programs and trade/industry careers leading to high wage, high skill, and high demand occupations. Students will explore a variety of disciplines and be directly involved in the development of course schedules, allowing them to gain hands-on experience in trades and professional occupations in a college/career environment. CIP funding would be limited to physical needs as identified at each of the schools.
