

Professional Qualifications

Please contact the school principal if you would like to learn about the professional qualifications of the teachers and paraprofessionals working with your child. Professional qualifications include:

- Whether the teacher has met state qualifying and licensing criteria for the grade levels and subject areas in which the teacher is teaching.
- Whether the teacher is teaching under emergency or another provisional status through which state qualifications or licensing criteria have been waived.
- The baccalaureate degree held by the teacher, and the field of discipline of certification or degree.
- Whether the child is provided support by paraprofessionals and, if so, their qualifications.

We are a Title I School



What is Title I?

Title I provides supplemental funding to schools to support students. Funding is based on the percentage of students qualifying for free or reduced lunch. Supplemental support can include: hiring teachers to reduce class size, additional instructional support, technology, family engagement activities, professional development, materials and supplies, and pre-kindergarten programs.

Your Student's Teachers Have Access to the Newest Research on Education through Title I Professional Development

Being a Title I school means the teachers have access to professional development *beyond* that which is already available to all educators in FNSBSD. Title I support for educators' continued learning is to help them address the unique needs of the students and their families, with evidence-based best practices. Title I professional development can take many forms and may include:

- Instructional coaching following an evidence based model
- Learning walks
- Substitutes so teachers can: review student data, create classroom materials, plan lessons and make decisions about how helping individual or small groups of students
- Classes on best practices in the education field
- Book studies on topics of particular interest to individual teachers
- Access to resources in the lending library

What will my students learn and how are the students assessed?

FNSBSD curriculum is designed to support students in meeting or exceeding State Standards. Parent guides to the curriculum are available on the district website or at your school.



Students in grades 3-9 are assessed annually for meeting State Standards in English Language Arts and Math using the AK STAR and for meeting grade level expectations in Science in grades 5, 8 and 10 using the Alaska Science Assessment.

Parents have the right to make educational decisions for their child, including whether to participate in statewide testing.
