As such, the performance on the Alaska School Performance Index (ASPI), is provided from 2013-14 (2014-15 ASPI was not calculated due to only one year of test scores for which growth scores would be unavailable).

Under ASPI, each school receives a score on a 100-point scale and a star rating from 1-star (lowest) to 5-stars. The ASPI score and star rating give an overall picture of how well the school is doing to prepare the students to be college-, career- and culturally ready graduates.
