# **Philosophical Foundation**

The Watershed School offers an education rooted in the philosophy and pedagogy of place-based education, defined by the Rural School and Community Trust (2003) as:

...learning that is rooted in what is local – the unique history, environment, culture, economy, literature, and art of a particular place. The community provides the context for learning, student work focuses on community needs and interests, and community members serve as resources and partners in every aspect of teaching and learning. This local focus has the power to engage students academically, pairing real-world relevance with intellectual rigor, while promoting genuine citizenship and preparing people to respect and live well in any community they choose.

Place-based education is closely related to and shares some fundamental elements of, environmental education, outdoor education, and community-based education. The model of place-based education used by the staff of The Watershed School integrates elements from these disciplines with the curricular content areas of reading, writing, math, science, and social studies.



# **School Improvement Initiatives**

The following school improvement initiatives for The Watershed School are framed within the five strategic goals of the Fairbanks North Star Borough School District's FY15-FY19 Strategic Plan.

### Personalized Learning

- The school overhauled its intervention program to better support struggling readers at the elementary level. Students needing additional reading support were identified through a process that combined teacher input and universal screening data. Teachers and aides adjusted schedules to ensure that intervention supplemented, rather than replaced, reading instruction in the general classroom. Student progress was monitored using classroom and standardized reading assessments. The school continues to work on researching and identifying ways to improve reading intervention methods, especially for older students. One of the challenges for the 2016-17 school year will be managing schedules with limited staffing to continue or increase the current level intervention support in reading and begin a similar program for math.
- Third through eighth grade teachers used Measures of Academic Progress (MAP) assessments from the beginning of the school year to develop Student Learning Objectives (SLOs), inform instruction, and provide additional information on student performance to parents and families. The school plans on continuing to use MAP in the future, but would like to adjust the timeframe in which the assessments are given so that accurate beginning, middle, and end-of-year data can be collected. The school is currently looking into professional development opportunities on more effectively using MAP data to support student learning.
- All sixth grade students were provided with subscriptions to ALEKS, an on-line adaptive math program. The ALEKS program was used to supplement general classroom instruction and provide both enrichment and remedial support for students.

### Effective Communication:

Head teacher, Jarrod Decker, helped transition the old school website to the new
district supported platform. The website continues to be a work in progress and will
need to be more regularly updated to be of use to families and community members in

- the future. Next year the school will begin using the district's BlackboardConnect text and voice messaging system.
- The Watershed School made several efforts to improve the way in which families are informed of the school and its application process. The school organized the Fairbanks North Star Borough School District's Schools of Choice Fair held on February 6, 2016 at the JP Jones Community Development Center. The fair provided families time to engage in personal conversations with representatives from the schools and learn more about the variety of programs offered by the school district. The FNSBSD Public Relations Department used social media resources to promote the Schools of Choice Fair.
  - Michael Campbell, School Liaison Officer for Ft. Wainwright, helped advertise the school's application window through military communications, including the Alaska Post.
  - The Watershed School also contacted preschool directors and posted notices about Watershed's application/enrollment period at over a dozen local preschools, day care centers, and the FNA Head Start program. Additional notices about informational meetings were posted in high-traffic areas all over town (FNSBSD office, Boys and Girls Club, Mary Siah Recreation Center, Fred Meyer, Children's Museum, coffee shops, toy/book stores, etc.).

### Parent and Community Engagement

The Watershed School continues to work on developing partnerships with community businesses and organizations. Service learning is a tenet of place-based education and one of the primary ways in which the students engage in the community.

- On Earth Day, every student and staff member spent the afternoon removing litter from the Smith Ranch neighborhood and local trails.
- Third grade students built and donated 30 bird feeders to the Alaska Songbird Institute.
   Several local schools and community organizations used the bird feeders to collect data for ASI's annual winter feeder bird count. ASI also sold bird feeders to help fund its research and educational outreach programs.
- The fourth grade classroom started developing a teaching kit that will eventually be donated and available for teachers and homeschool parents to check out from the UAF Museum of the North. The kit focuses on the salmon life cycle and emphasizes the

importance of the marine-derived nutrients salmon carry in their upstream migration to Interior Alaska. Students began the work of creating a model red (salmon nest), creating teaching games, posters, PowerPoint presentations, and a map depicting nesting streams in Alaska.

- Students in the sixth grade class continued their two-year partnership with Raven's
  Landing. The class spent a few days with the residents of Raven's Landing, including a
  Christmas cookie baking session for local homeless teens.
- Sixth grade students held a coffee drive for a Watershed parent and his unit deployed to Afghanistan.
- The fifth grade class participated in the King Arthur Flour Bake for Good program for the second consecutive year. The class learned how to bake bread in school, and then took home kits with flour, yeast, and recipes to bake additional loaves at home. Students baked and donated over 30 fresh loaves of bread to the Fairbanks Community Food Bank.
- Second grade students were in charge of this year's canned food drive. The food drive
  directly related to the community-based social studies curriculum the students were
  engaged in this winter. Students also applied their math and writing skills to calculate
  the daily and cumulative weight of donated items and to create posters advertising the
  drive.
- The kindergarten class raised chickens and regularly delivered eggs to Grandma Francis, a neighbor who generously allows the school to use a natural corner of her property for various classroom activities (nature journaling, science investigations, birch sap collecting, etc.). The kindergarten class also raised red worms that were given to the Noel Wien Library to feed the turtles in the children's area.
- All classrooms grew vegetable and flower starts in the spring that were sold during the
  last two weeks of school. The school donated proceeds from the plant sale to the Nordic
  Ski Club of Fairbanks Trail Fund.

### Organizational Support

 One of the challenges that many teachers at The Watershed School have expressed is balancing curricular demands with the need to regularly take students on outings to natural areas. Teachers want opportunities to learn ways in which they can further incorporate weekly walks in the woods into the curriculum they cover in the classroom. To help meet this need, Mike Taras, Education Specialist of the Alaska Department of Fish and Game, provided a full-day professional development session on wildlife tracking with all the teachers and support staff on February 5, 2016. The staff spent most of the day in the field practicing the observation and inference skills necessary to determine the species of animal that left the tracks and the direction it was traveling. Teachers and other staff members discussed how they could take the wildlife tracking knowledge they gained to develop engaging language arts, science, and math lessons for students.

The Watershed School, along with the rest of the school district, implemented the
 Danielson Framework as an evaluation tool. Teachers worked in Professional Learning
 Communities (PLCs) to develop and monitor Student Learning Objectives.

### <u>Technology Integration</u>

- The Watershed School now offers 1:1 laptop computers for students in third through eighth grade. Keyboarding skills are introduced in third grade, and a variety of software programs are used to enhance learning and produce high-quality projects at each grade level (3-8).
- The middle school science and language arts teachers collaborated on a year-long climate change project that incorporated time-lapse photography of seasonal change on the school trail system.
- The school has been fully integrated into the district's Destiny system. Library Media
  Associate, Amy Kulp, regularly helps staff and students use Destiny to access relevant
  materials and information.

### <u>Transiency</u>

Seven students have transferred from The Watershed School to other FNSBSD schools in the past two school years. We are projecting that over 97% of our current students in kindergarten through seventh grade will return for the 2016-17 school year.

### The Watershed School Activities

### **Outdoor Learning Experiences**

The Watershed School continued its dedication to providing students with experiences that enhance their outdoor survival and recreation skills. Through ski outings, camping trips, and regular walks in the woods, students developed deeper connections to their environment, gained self-confidence, strengthened bonds with classmates through shared experiences, and engaged in activities that promote healthy lifestyles. Here are a few examples of outdoor learning experiences from this year:

- Eighth grade students took a week-long trip to Kachemak Bay. Students participated
  in a program lead by the Alaska Center for Coastal Studies, tried their hand at sea
  kayaking, explored tide pools, and learned about Alaska's marine and temperate
  rainforest ecosystems.
- Seventh and eighth grade students spent three days winter camping at Lee's Cabin
  in the White Mountains this March in conjunction with the Bureau of Land
  Management's Hands on the Land Program.

- Eighth grade students learned the basics of rock climbing from at Grapefruit Rocks in May from the instructors with the UAF Department of Recreation, Adventure, and Wellness.
- Middle school students studied and received hunter education certification. Seventh
  and eighth graders also participated the Kids Don't Float boat safety program led by
  Brian Charlton, Park Specialist for the Chena River Recreation Area. The program
  included classroom lessons and applied in-canoe practice at the Hamme Pool.
- Sixth grade students spent three days in Denali National Park, highlighted by 38-mile mountain biking trip from the Teklanika River to Polychrome Pass.
- Fifth grade students spent three days camping and off Chena Hot Springs Road and explored the Granite Tors Trail.
- The third and fourth grade spent three days camping in the Chena Recreation Area.
   The trip was highlighted by a hike from Angel Rocks to Chena Hot Springs Resort
   (with swimming and soaking afterward!).
- Favorable snow conditions allowed for the return of Watershed's annual All School
   Ski Day, in which all students and staff members spend an entire day cross-country
   skiing and playing ski-related games at Birch Hill Recreation Area.
- Second grade students were introduced to Watershed camping trips with an overnight camp-out in the schoolyard and a day of fun at Tanana Lakes.
- Students in each grade level went on numerous outings to local trails (Birch Hill, Isberg, Creamer's Field, Goldstream Valley, Goldstream Sports).

### **Other Notable Events**

• The Watershed School hosted one of the district's cross-country running races for elementary students in September. Hundreds of students from across the district were able to participate thanks to nearly 70 volunteers from Watershed and other schools. Students from The Watershed School have been enjoying these races for years, and we plan on continuing to host elementary races in the future. The middle school race The Watershed School has hosted for the past three years was canceled due to dangerous trail conditions. The Watershed School PTSA also hosted its second annual 5K race in October.

- The Watershed School had over 80 students participate in the Battle of the Books program. Lori Schoening, a parent volunteer, serves as the head coach and is driving force behind the success and popularity of the program. Watershed's Library Media Associate, Amy Kulp, and parent volunteer Ginger David were also key contributors to the program. The Watershed PTSA continued to purchase books that were used by student participants and later included in the general library collection. Watershed's 3rd/4th and 5th/6th grade teams were the district champions and advanced to the state competition.
- The Watershed School's MathCounts team placed second in the district competition and advanced to the state-level, where they finished fourth. The team is coached by Lisa Beattie, the middle school science and math teacher.
- Moira O'Malley, the first grade teacher, was named a 2016 BP Teacher of Excellence.
   Ms. O'Malley has been teaching at The Watershed School since it opened in 2009.

### **Exploration of school relocation**

Sam Decker and Tiffany DeRuyter have begun researching possible school relocation.

Banks give the indication that Watershed can afford a \$ 6 million dollar loan.

Architects have been contacted (Bettisworth North and Design Alaska) and have given a quote of \$ 4.5 million for the building.

Multiple locations have been studied. Each location has strengths.

Sam and Tiffany will be meeting this Saturday, Sept 19 at 1 pm. They are looking for others to help with this research project.

### **Report Card to the Public**

No report card is available to the public yet. Anticipated release timeframe is mid-October. It should be expected that test scores will go down due to new mechanism and new test.

### **Staffing**

Zero turn-over from last year.

### After-school care

First attempt at establishing after-school care was not successful. PTSA is now researching a PTSA-sanctioned community effort.

### Air-quality

The air quality monitoring station is returning. Owners of the station will pay for electricity. Watershed will get real-time feedback, which will be highly valuable in planning outdoor activities.

### **Budget**

The budget is still being updated. Last year, Watershed prepaid this year's lease in the amount of \$350,000. The district is building a multi-year plan including all-day kindergarten, a magnet school and improved district communication. Jarrod Decker is working on an on-site plan for Watershed.

### **Accessibility of Watershed**

The APC is aware of the diversity numbers within the school. The following steps are being taken to make this school more accessible:

- 1. Working on an after school program
- 2. Researching a new school location
- 3. Continuing to be open to viable bussing options

- 4. Increasing awareness of the school to recruit new students: advertising with flyers and in the newspaper
- 5. Establishing a more encompassing way to recruit new APC community board members
  - a. Advertise for this position in preschools, daycares, community areas
  - b. Letter of interest may include some or all of the following: why applicant is applying for this place-based/outdoor education position, what applicant can contribute to the school, applicant's board experience, statement of the value of community and outdoor in their own lives and/or anything else the APC board should know about the applicant
  - c. Process for evaluation will be established with the goal of making decisions in November

Goal: to become a more accessible school.

### **School updates**

- a. MAP testing this week: new nationally-normed test for 5th and 7th grade.
- b. School of choice fair was this past Saturday and was well-attended.
- c. Classes continue to work on great projects. Some examples:
  - Kindergarten is growing worms to feed to the box turtle and building chicken coop.
  - Second grade hosted a food drive.
  - Third/Fourth grade will do the confluence ski on February 19. Fourth just completed Moon Journals.
  - Fifth did a bread-baking project.
  - Sixth continues the relationship with Raven's Landing and completed a coffee drive.
  - Seventh/Eight is getting ready for their White Mountains trip in March.
- d. Staff Development Day was February 5th. Topic: tracking wildlife with F&G
- e. Daily schedule changed recently: lunch time is reduced by five minutes and library time is increased by five minutes.

### All-school ski

All-school ski is on March 8. District busses will transport to Birch Hill and charter busses will bring students back to school. PTSA will pay for food.

Proposal: Watershed uses Birch Hill frequently through the winter for ski club and field trips. Can the non-profit Watershed Foundation make a donation to NSCF for grooming at Birch Hill? The foundation has a balance of \$4,200. Discussion included ways the foundation receives income. Are these streams of income consistent, such that a trail donation can be made each year? The plant sale generates money for the foundation each year. A portion of the plant sale will be used to make the Birch Hill trails donation, allowing the whole school to participate in this donation.

### Attendance

This year Watershed has had two attendance policies: the school policy and the district policy.

Background: Chronic lateness of fifteen minutes or more in Watershed's first years resulted in establishing the policy of counting any tardy greater than 10 minutes as a half-day absence. This significantly cut down on the number of tardy students.

This year, the district level instituted a new attendance policy: fifteen unexcused absences result in a monetary citation with incremental increases in fines as unexcused absences increase. "Unexcused" is defined as parents not contacting school administration to excuse the absence.

Issue: Watershed's absence rate is artificially high due to the number of ten minute tardies labeled as half-day absences. Parents with students tardy by more than ten minutes often do not make contact with the school, so these are counted as half-day <u>unexcused</u> absences. Many potential solutions were discussed and the limitations of reporting in PowerSchool were kept in mind. The goal is to better align the school policy with the district policy, such that Watershed maintains the incentive to be on time but does not report an artificially high number of half day absences, many of which are unexcused.

# **Appendix C: Bylaws**

### **Article I-Introduction**

These bylaws shall govern the internal policies and procedures of the Membership Association and the Board of Directors of the Watershed School.

### **Article II-Purpose**

The mission of The Watershed Charter School is to provide a meaningful education that challenges students to know and care for themselves, their community, the Tanana Valley, and their world.

### **Article III-Membership Association**

Section 1. *Eligibility:* Any voting aged adult residing in the Fairbanks Northstar Borough shall be eligible to join the Membership Association. The board may provide for non-voting memberships for organizations or individuals wishing to support the Watershed School that do not meet the above criteria.

Section 2. *Dues:* Annual membership dues for individuals shall be ten dollars for individuals and twenty dollars for families. Dues shall be paid upon application for association membership and, hereafter, annually by September 30th. Annual dues shall be for the period October 1<sup>st</sup> through September 30th or any portion thereof.

Section 3. *Voting:* Any eligible person present at a Membership association meeting who has paid the current dues at least ten days prior to meeting may vote on business before that meeting.

# **Article IV-Membership Association Meetings**

Section 1. *Annual Meeting*: The Membership Association shall meet at least once annually at a place and on a date determined by the Board of Directors. Notice of the Annual Meeting and a proposed agenda shall be mailed to all members at least two weeks prior to that meeting. Public notice of the meeting shall be published in a newspaper of general circulation in the Fairbanks Northstar Borough area.

Section 2. *Special Meetings:* In addition to the Annual Meeting, special meetings of Membership Association may be called by the Board of Directors. Special meetings may also be called by petition of ten persons within the Membership Association who are not members of the Board of Directors. Any such petition shall state the subject to be considered at the meeting, and only the subject shall be considered at the meeting. Any such petition shall be delivered to an officer of the Board, which shall call the meeting for within thirty days of receipt of the petition and shall deliver the requisite notice

thereof to the membership.

Section 3. *Quorum:* The majority of the occupied seats of the Board plus any Association members present shall constitute a quorum for the conduct of business at annual and special meetings provided that the total of those present, in person and by proxy, represents at least 1/10th of the total membership of the association.

### **Article V-The Board of Directors**

Section 1- *Election*- The Board of Directors shall consist of eleven persons who are voting members of the Membership Association, and whom four shall be elected by the Membership Association and seven by the Board of Directors. The term of office shall be two years, with staggered terms so that a proportional number of seats become vacant each year. A board member may serve for unlimited terms.

Section 2- *Officers*: There shall be four officers of the Corporation: President, Vice President, Secretary, and Treasurer. The Board shall elect its officers annually immediately following the annual general meeting. The duties of the officers are listed below.

- a. *President:* The president of the corporation will be the principal officer and Registered Agent for the corporation and will in general, supervise the business and affairs of the corporation, preside at all meetings of the corporation, and shall sign contracts or other instruments that the Board of Directors has authorized to be executed.
- b. *Vice-President:* The Vice-President will perform duties of the President in the absence of the President or in the event of the inability or refusal to act of the President, and when so acting, will have all the powers of and be subject to all restrictions upon the President.
- c. Secretary: The secretary shall be responsible for minutes of all meetings and all correspondence of the Board and shall keep at the registered or principal office a record giving names and addresses of the members entitled to vote. The Secretary shall be responsible for keeping the records of attendance at all Board meetings and for advising the President, in writing, when a Board seat becomes vacant in accordance with the requirements of Section 6, of this Article.
- d. *Treasurer:* The Treasurer shall be responsible for correct and complete books and records of accounts.
- Section 3. *Quorum:* A majority of the occupied seats of the Board shall constitute a quorum for the conduct of business.

Section 4. *Meetings:* The Board shall meet monthly, or more frequently as the Board deems necessary. All meeting shall be open to public participation.

Section 5. *Executive Sessions:* For discussion of matters relating to personnel and possible litigation only, the chair shall upon request of any member of the Board declare an executive session.

Section 6. Attendance: When a member of the Board fails to attend three consecutive Board meetings, or five meetings in a twelve month period, that seat may become vacant if a majority of the Directors votes for removal of the absent Board Member. That seat would then become automatically vacant, and a replacement shall be chosen as provided in these bylaws.

Section 7. *Vacancies:* When a seat on the Board becomes vacant during a term, that seat shall be filled by a majority vote of the Directors. The appointed member shall serve out the unexpired portion of the term of that seat to which she or he is appointed.

### **Article VI-Parliamentary Rules**

The most recent edition of Robert's Rules of Order, Newly Revised, shall govern procedures not covered by these bylaws.

### **Article VII-Committees**

The Board may appoint committees as necessary to conduct its business.

# **Article VIII-Reports**

Annual Report: The Board of directors shall submit an annual report on the financial condition and progress of the Watershed School to the Membership Association. The report shall be mailed to every member and shall be made available to the public.

### **Article IX-Conflicts of Interest**

When a member of the Board of Directors believes he or she may have a conflict of interest, financial or otherwise, on any matter before the Board, or when a member believes otherwise, that question shall be raised prior to any discussion of the matter, and the chair shall rule on the issue. The ruling of the chair may be sustained or overruled by the Board. If a conflict is found to exist, the member having the conflict shall refrain from discussion, and shall refrain from voting on the matter.

### **Article X-Amendments**

Amendments to these bylaws may be initiated by either the Board of Directors or the Membership Association. Amendments must be approved by the Membership Association, by a simple majority when the amendment is also approved by the Board, or by a two-thirds majority when the amendment fails to gain Board approval.

### **Article XI- -Effective Date**

These bylaws shall be effective upon approval by the Board of Directors, and shall be submitted to the Membership Association at its first meeting

thereafter for ratification.

**Article XII)** The Watershed School is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article XIII)** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the borough in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
