The administration would develop a draft of the board's Legislative Priorities Brochure based upon the input provided by the committee for review at a future meeting.

Legislative Strategy Discussion [0:33:19]

The committee considered different legislative strategies and approaches, including:

- Thematic/Multi-Faceted Approach
 - Based on Strategic Plan Investing in Education through Personalized Learning
- Utilizing a Lobbyist
- Board/Administration Visits with Interior Delegation in December
- House
 - Four Interior Votes in House Finance
- Senate
 - o Fairbanks Strength

The administration would develop a bullet-list of talking points for board members to use in their discussions with legislators.

Lobbyist Discussion [0:47:15]

The committee discussed the pros and cons of hiring a lobbyist. Lobbyist costs were included in the 2016-17 budget at \$45,000 – which would include a base contract amount and actual travel expenses. There was consensus from the committee to hire John Ringstad as the district's lobbyist for the 2017 legislative session at the same amount as last year - \$36,000 for the base contract and actual travel expenses. The lobbyist contract would be added to the December 12 special meeting agenda for action by the school board.

Mr. Ringstad joined the discussion and provided the committee with his perspective on the upcoming legislative session, along with an overview of possible educational legislation and other bills of interest.

Committee Comments/Announcements [1:15:57]

Mr. Ringstad would schedule meetings with Interior Delegation members during the month of December to meet with Dr. Gaborik, Mrs. Pearce, Mr. O'Brien, and Mrs. Haas. Board members, the administration, and Mr. Ringstad would work on upcoming dates for Juneau visits to meet with legislators.

The 2017 30th Legislature, 90-day legislative session was scheduled for January 17 – April 17, 2017.

The committee meeting adjourned at 6:58 p.m.
