After a discussion of the November 9, 2016 minutes, a motion was made by Dawn Murphy to approve the minutes, which was seconded by Joni Simpson. The minutes of November 9, 2016 were approved.

#### PUBLIC COMMENT ON NON-AGENDA ITEMS

- 1. April Scott Curriculum Review Process: CTE Adoption based on clusters. Architecture & Construction, Capstone, and Hospitality & Tourism. Process discussed: Board Curriculum Advisory Committee (BCAC) / Board Approval. New Capstone course in Work based Learning and Apprenticeships / Internships.
- 2. April Scott College and Career Fair: Counselors want to reinvent college fair to include more career paths to include trades and military. They would like to explore making it conference style with workshops available for a full day venue. Event may be catered by high school students and possibly supported by student business enterprise. Want to provide an avenue where students would be more engaged in the process. October 18<sup>th</sup> / 23<sup>rd</sup> are possible dates. Venues discussed. Meetings and conventions department discussed by Dawn Murphy.

- 6. Joni Simpson Counselor Ben Eielson High School (BEHS) Assist students finding their career pathways.
- 7. Andrea Gelvin Healthcare statewide with emphasis on First Aid and CPR.
- 8. Nicole Piazza Fort Wainwright Career Services assists all Department of Defense employees / dependents.
- 9. Dawn Murphy Explore Fairbanks Tourism Industry and workforce development. Interior Tourism Conference noted with associated job fair. ~200 people attended from schools / military. Alaska Host classes noted. ~\$63 million in revenue from tourism bed tax. Arctic Nations conference coming in early May.
- 10. Mike O'Brien School Board Attorney and works with the University. CTE is all career paths, not just trades. Interested in learning more.
- 11. Chad Hutchinson Director of Fairbanks Pipeline Training Center (FPTC). Fortunate to get to work with all trade groups. Noted addition of Building Trades this year in addition to Welding and Electrical.
- 12. Robyn Taylor Hutchison High School (HHS) Principal. HHS is finishing recruiting and enrollment season for incoming freshman. Kudos to school board for strategic plan and personalized learning. Fifty-four (54) part time students for career clusters attend HHS. Opportunities expanding for students. How can we unify and create more opportunities for students? Thirty-four (34) students going to West Valley High School (WVHS).

- 1. PERKINS REALLOCATION:
  - a. CTE Course offerings discussed as pertains to Carl Perkins funding specifically in relation to CNA classes. Certifications discussed.
  - b. Non Traditional Occupations (NTO) discussed for district as well as nation.
    - iii. How do we attract and set up students for success in NTO?
      - 1. Cohorts discussed.
      - 2. CNA course counselors recruit from schools. Allied Health has more males in healthcare than represented in school district class. Males encouraged by Allied Health.
      - 3. Gelvin Career Investigations course discussed as means to get interest in NTO's involved.

- 4. Simpson Starts in schools with aid of counselors. Counselor professional development. NTO role models to lead cohorts.
- 5. Watch for inherent bias and standards are upheld. Be sure that content is not simplified for different populations.
- 6. Whistler Female teaching IBEW class. Bringing female apprentices to trade shows / career fairs to start the conversations and / or younger apprentices to bridge the gap.
- 7. Plutt Early apprentices and females go to the career fairs to reach students on their level.
- 8. Taylor HHS intentionally put students in mentoring role for NTO for gender and ethnicity. Female, native student promoting program for Architecture and Construction and male student for Health Sciences.
- 9. Scott Put a lot on the counselors to make suggestions. What are the attributes to direct into career paths. Assessments discussed.
  - a. Wendell PD day to tour apprentice programs with roundtable to follow.
- 10. Geese Showing students what is offered. Not really apparent until Junior year. Earlier introductions to what is available with more details requested.
- 11. Murphy Middle School career day
- 12. Whistler A day in the life of...IBEW, Plumbers...
- 13. Hutchinson Counselors brought to the school with instructors and directors to understand the program.
- c. Completers discussed. Need two (2) complete years for CTE completer status.
- d. ESSA vs NCLB discussed. Freedom to further explore local opportunities.
