Overview

Evaluations and feedback from Family Nights/Events are collected, reviewed and directly influence the direction of future events.

Popsicles with Parents - August Families attend with students to pick up schedules, meet teachers and staff, open lockers and tour the school. Information will be available and the principal will be in a centrally located place where parents can ask questions and learn about our Title 1 plan. A parent survey will be conducted to identify when parents can meet and what topics they might be interested in. Families will also have an opportunity to sign up to be a part of our Title 1 team.

Family Drive in Movie Night - October 15 End of the Quarter family activity. We will host the drive-in movie and team teachers and admin will be available to answer questions parents may have regarding their child's academic, social and emotional well being. We will also have secretaries available to help parents get connected to PowerSchool to be able to track their students grades and attendances.

Bring Your Parent To School - October 22 & February 11 - Families attend school for the day with their child experiencing middle school with their child, following daily schedules and interacting with the curriculum in all classes. Parent break room will be set up so that parents have a place to get coffee and snacks and learn more about our Title 1 plan.

Fun In the Sun- Parent engagement event where parents will attend different activities and workshops that help them to address academic support with a focus on our Career Exploration discussions that are happening in Advisory Classes.

Honor Merit Tea- April - Annual event where families are invited to celebrate with us their child's success. Students and families are served tea and coffee by the staff and staff interact with families in a more casual setting.


